10.11: Introduce and Waive the First Reading of an Ordinance Amending Chapter 19, Article VIII of the Oakdale Municipal Code relating to Oakdale Massage Establishment Regulations.

A PowerPoint Presentation was provided.

Lieutenant Carrillo presented the staff report that recommending the City Council introduce the Ordinance amending Article VIII of Chapter 19 of the Oakdale City Code relating to Oakdale massage establishment regulations and waive the first reading.

Council Member Bairos questioned how the request to amend the ordinance came about and if there was a specific concern regarding the Oakdale massage establishments or if this was a state recommendation. She asked if the Oakdale establishments had been notified by either the City or the state of these proposed changes or if this was a first step. Lieutenant Carrillo responded that there is a concern regarding the Oakdale establishments but that this is a first step. She also asked for clarification on CAMCT certification and how the monitoring process would work.

Council Member Smith asked Lieutenant Carrillo if he knew how many existing establishments in Oakdale were in CAMCT compliance. Chief Heller stated he believes the majority of establishments are in compliance rather than not in compliance and that this is just a matter of updating our ordinance to be consistent with other municipalities throughout the state. Council Member Smith expressed concern over putting legitimate establishments through undue hurdles if they are already in compliance with current state requirements.

Council Member Chiara asked about the option current businesses have, if they are not CAMCT certified, to fill out an application for background check. Chief Heller said this was an option.

Council Member Murdoch questioned whether this could potentially put anyone out of business. Chief Heller responded that current businesses fall under the current ordinance and would have been approved under city administration, including a full background check from the police department. Those businesses would already be in operation. New Businesses would need CMACT certification or go through an extensive background such as what Council Member Chiara had just spoke about. City Manager Whitemyer added that, in essence, existing businesses who are in compliance with the existing standards, would be grandfathered in. Council Member Smith stated that he didn't see any mention of this in the Ordinance and he would like to see that additional language added to the Ordinance.
