10. Public Hearings

10.1: Introduce and Waive the First Reading of an Ordinance Introducing Chapter 36-29 Mobile Food Vendor and Amendments to Chapter 36 Zoning Regulations Sections 36-10.5, 36-11.3, 36-12.5, 36-13.5, 36-15.5, 36-18.6.

A PowerPoint Presentation was provided.

Management Analyst Andersen presented the staff report on an Ordinance introducing Chapter 36-29 Mobile Food Vendor and Amendments to Chapter 36 Zoning Regulations Sections 36-10.5, 36-11.3, 36-12.5, 36-13.5, 36-14.5, 36-15.5, 36-18.6. She explained that the proposed Ordinance established regulations for mobile food vendors by adding Mobile Food Vendor Section 29 to the Chapter 36 Zoning of the City of Oakdale Municipal Code. The proposed regulations would allow mobile food vendors to operate on private

property and within the public right-of-way in certain areas of the city, subject to location, operation, standards and requirements and in some cases subject to Planning Commission consideration. It would also establish a procedure for the review and approval of mobile food vendors through the process of either a Minor Use Permit for use on private property, Major Use Permit for use in the public right-of-way and Sidewalk Vendors through an Annual Temporary Use Permit. Management Analyst Andersen concluded her report requesting the City Council introduce and waive the first reading of the proposed Ordinance.

Staff responded to questions asked by the City Council and with no further questions, Mayor Bairos declared the Public Hearing open for public comment at 7:28 p.m.

Andrian Panetta asked a question regarding mobile food trucks.

Paul Rivera spoke about business licenses and mobile food vendors.

Alice Garcia spoke against businesses using sidewalks for dining areas, especially on the streets with bulb out curbs.

There being no further public testimony, Mayor Bairos closed the Public Hearing at 8:02 p.m.

Mayor Bairos then asked if anyone would like to make a motion on this item.

11.1: American Rescue Plan Act Expenditure Plan discussion.

City Manager Whitemyer provided a staff report on the American Rescue Plan Act (ARPA) Expenditure Plan. He explained that the Act establishes the Coronavirus Local Fiscal Recovery Fund which is intended for local governments like the City of Oakdale. It was previously reported that the City of Oakdale would receive \$4.4 million over two years; however, the City received notice indicating that the actual amount of ARPA funding the City will receive is \$5,644,664 or \$2,822,332 over the next two years. He stated that the City recently received its first payment of \$2,822,332.

City Manager Whitemyer discussed various projects that the funds could be allocated for including possibly doing another RAD Card program, only citywide.

He stated that this item will be presented at the upcoming City Council Goal Setting Session Follow-Up meeting where the City Council can develop a formal American Rescue Plan Act Expenditure Plan.

Staff responded to questions from the City Council.

Mayor Bairos opened Public Comment for this item.

With no further public comment, Mayor Bairos closed Public Comment.

12. City Manager's Report

City Manager Whitemyer thanked all the surrounding allied agencies who provided assistance to Oakdale PD during an incident involving an officer.

13. City Council Items

13.1: Consider a Resolution of the City Council of the City of Oakdale Designating a Voting Delegate and up to two (2) Alternates to take action on Resolutions that establish League of California Cities Policy at the Annual Business Meeting on Friday, September 24, 2021.

City Manager Whitemyer provided a staff report to the City Council regarding the League of California Cities' Annual Business Meeting scheduled for Friday, September 24, 2021. This year's event will be held in Sacramento, California. He explained that in order for the City to take action on Resolutions that establish League policies, the City Council will have to designate a Voting Delegate, and up to two alternates, to represent the City at the Annual Business Meeting.

The City Council asked questions of staff which were responded to by staff. It was decided that City Manager Whitemyer would serve as the City's Designated Voting Delegate at the League of California Cities' Annual Business Meeting.
