**3. PUBLIC COMMENT**

**4. PRESENTATION AND DISCUSSION OF SB 1383 AND IMPACTS TO GARBAGE RATES BY GILTON SOLID WASTE MANAGEMENT.**

City Manager Whitemyer provided an introduction to SB 1383 and briefly described the topics to be covered this evening. He then introduced Tracy Norris from Gilton Solid Waste Management who provided a PowerPoint Presentation regarding SB 1383. Her presentation covered long-term sustainable solutions and research findings related to compost technology and permitting, waste character studies and collection service costs.

Ms. Norris reviewed the collection service costs and provided a breakdown of organics cart rate, MSW cart rate, commercial bin rate and franchise fee. She also discussed the need to develop a new contract agreement to include approval of the new rates, longer agreement term, and auditing and oversight requirements that previously didn't exist prior to SB 1383.

Ms. Norris and representatives from Gilton Solid Waste Management responded to questions from the City Council.

City Manager Whitemyer stated that the Public Hearing would go before the Council on December 6<sup>th</sup>.

Richard Gilton also provided information on the mandate.


